# Overview

Half-day event within the STAC Summit focused on solution stacks driving the finance industry's rapid AI adoption, including data exploration, training, inference with deep neural networks (especially LLMs) and statistical machine learning.

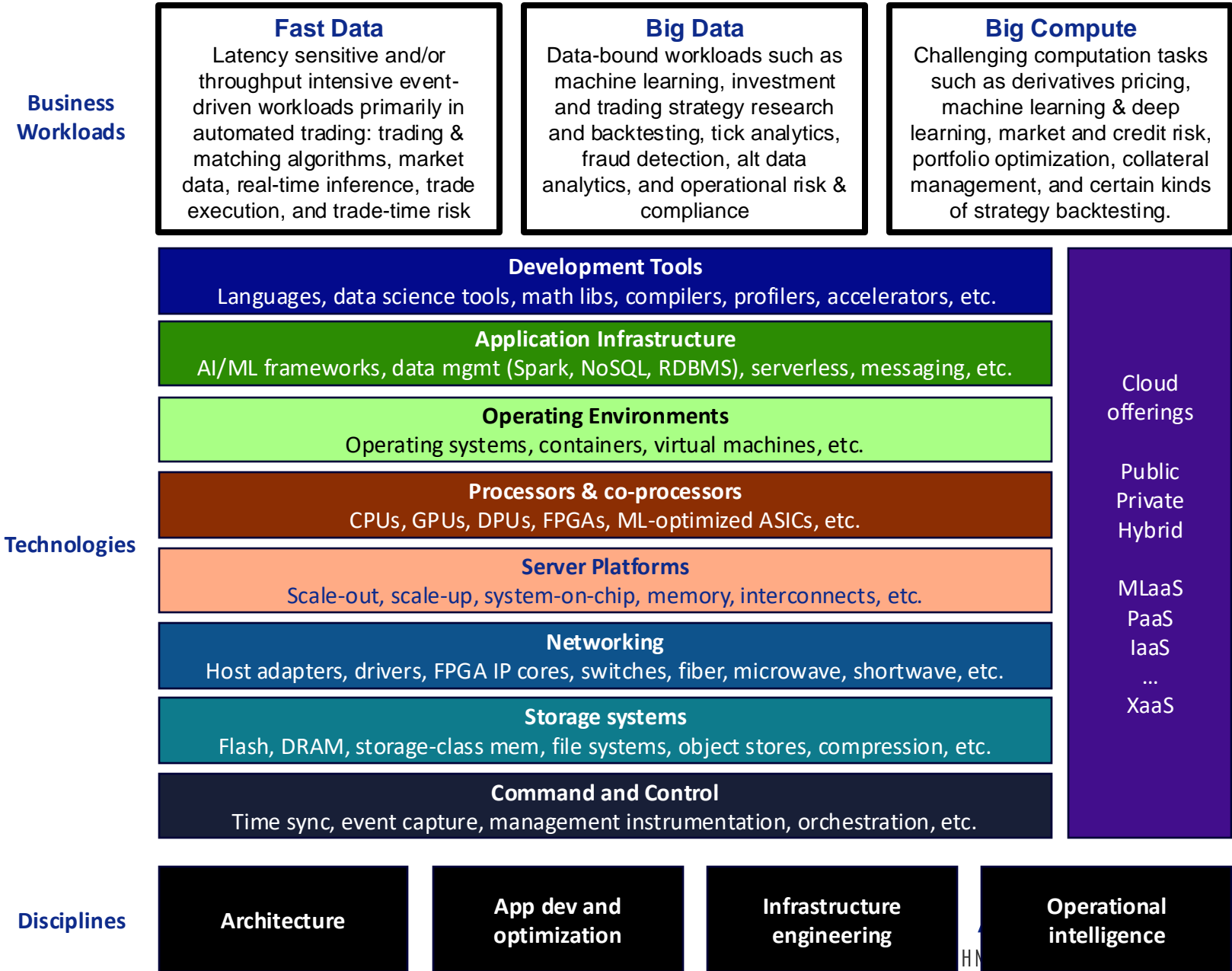

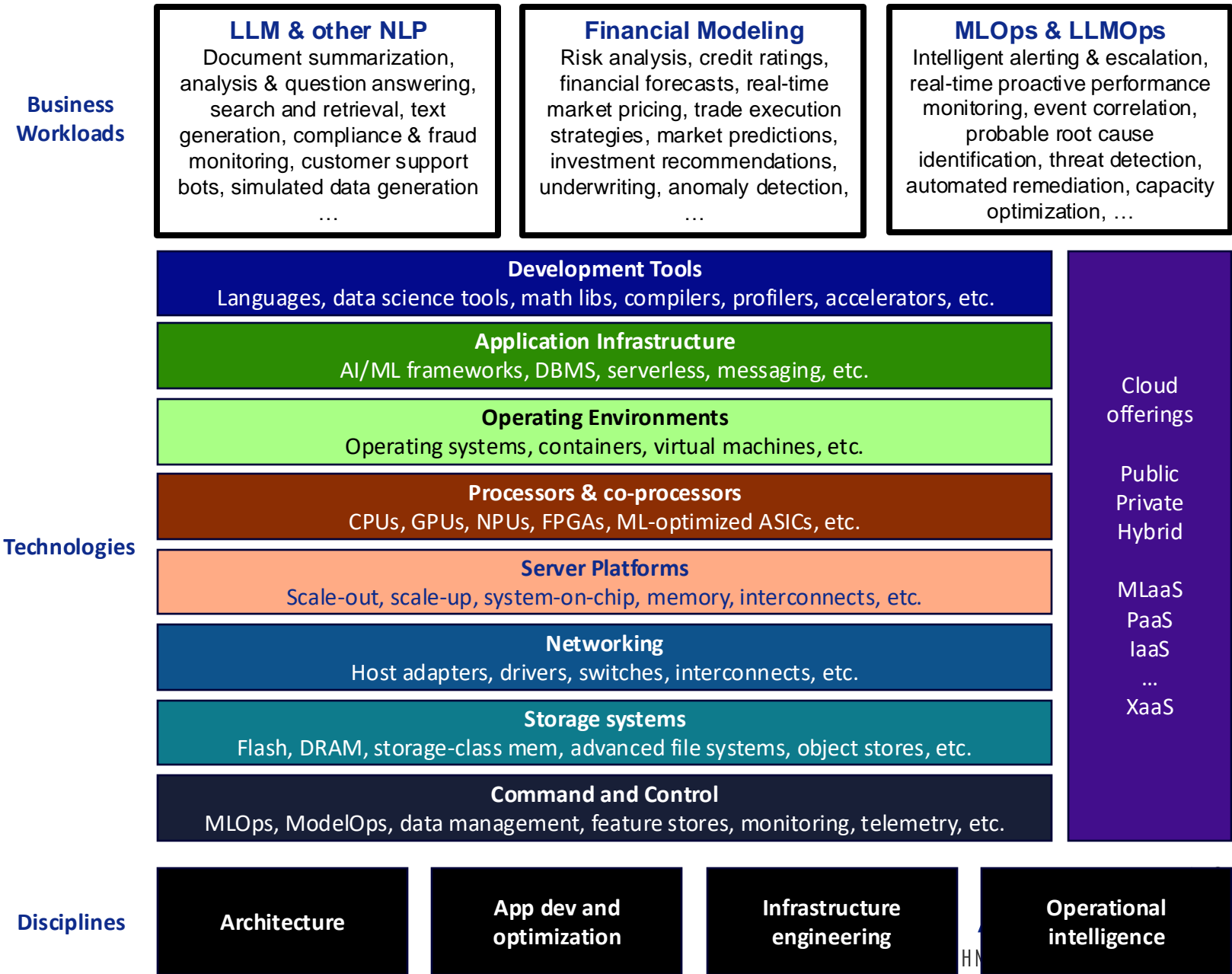
- **STAC Summits** are full-day events including a lunch, breaks and post-event reception.

# STAC Event Attendees

- The 2023 & 2024 STAC Summits saw record attendance and growth, with attendance by technologists at financial firms growing 25% from 2022 and new records in 2024.
- AI STAC launched in late 2023 to much fanfare. Due to the overlap in topics and vendor feedback, STAC has decided to integrate AI as a track within the core STAC Summit. This offers maximum benefit to sponsors to reach the optimal and broader range of attendees with their solutions and budget.
- A big part of STAC Summits' success is the breadth and depth of technical content we bring to the community. STAC Summits attract the **highest quality technical audience in the business**. Over half the titles of user attendees at STAC Summits are in technology management, with 40% being Director level or above.
- STAC Summit content and attendee policies are specifically designed to deliver a high ratio of end users to vendors, which is loved by the end users and beneficial to vendors!

# Speak, and be heard!

- The **Innovation Roundup (IR)** is an inexpensive way for vendors to generate awareness and well-qualified leads by exposing customers to new technologies in a punchy, “get to the point” way.
- Each IR presenter has **5 minutes** to present to the full audience, in roughly the following format:
  - What’s your technology?
  - How can it help a trading firm?
  - What actions would you like the attendees to take?
- The value of the IR is that “one-to-many” captive audience experience.



- An **Innovation Deep Dive (IDD)** is a presentation on a particularly interesting technical topic, typically **12-15 minutes in length**.
- Unlike an Innovation Roundup presentation must be solely for the purpose of illustrating an industry-level point of view. Vendors wishing to be considered for a Deep Dive must discuss the topic and speaker with STAC at least 30 days in advance. STAC will, in its sole discretion, determine whether the proposal is appropriate for the given event.
- STAC will collaborate with the vendor to shape the content for the STAC audience and to craft an agenda description in STAC's voice.



- A **Panel discussion** typically involves multiple vendors, customers, consultants, and/or analysts, moderated by STAC or an industry expert.
- They are usually 35 to 45 minutes in length.
- Panel participants are expected to have interesting things to say about the topic from an industry perspective and should refrain from overt sales pitches.

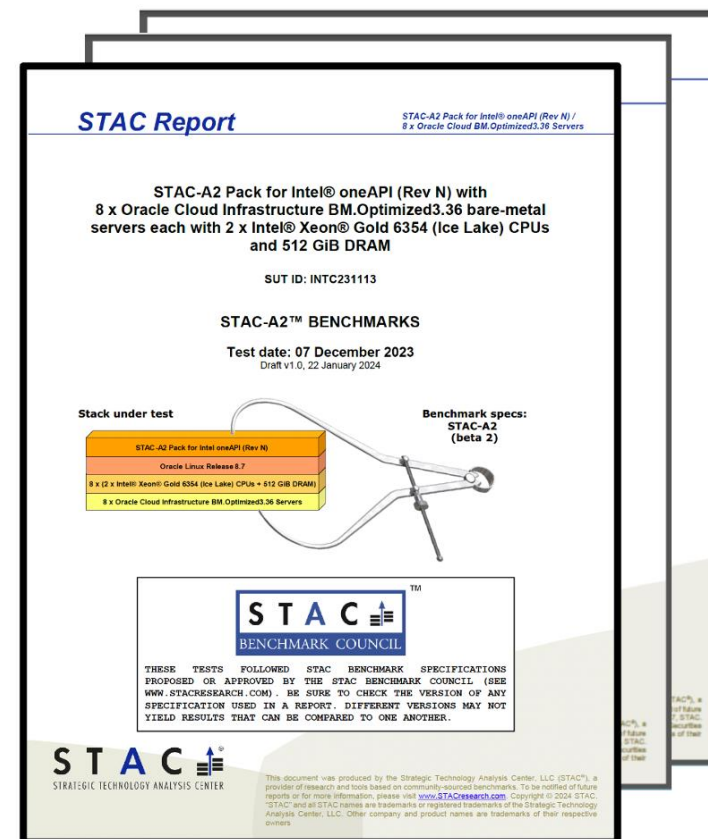
